

Embassy of India, Ouagadougou (Burkina Faso) is collecting all the documents required for visa and passport services and forwards the documents to HCI, Accra as Consular service is not fully functional yet. The fees collected is as per the fee schedule fixed in US\$ by HCI, Accra and converted into local currency of Burkina Faso (along with return courier charges). Mission is awaiting the visit of IVFRT team of Government of India in order to start its consular services fully in the Mission. (Documents collection and delivery timing 09.30 a.m to 12.30 p.m.( Monday to Friday working days not included Public Holidays). Fee Schedule is given below.
