(i)	The particulars of its organization, functions and duties;	<p>The Embassy is headed by the Ambassador of India and supported by Second Secretary who looks after the various matters relating to Political, Commercial, Consular, Cultural etc.</p> <p>The Embassy functions within the purview of business allocated to the Ministry of External Affairs under the Government of India Allocation of Business Rules and Transaction of Business Rules. The functions of the Embassy inter alia include political and economic cooperation, trade and investment promotion, scientific &amp; technological cooperation, cultural interaction, press and media liaison, and consular operation including PIOs/NRIs, in bilateral and multilateral contexts.</p>
(ii)	The powers and duties of its officers and employees:	<p>General Administrative powers are derived from IFS (PLCA) Rules, as amended from time to time.</p> <p>The financial powers of the Officers of the Embassy of India have been detailed in the Delegated Financial powers of the Government of India Representatives Abroad. Other powers are derived from the Passport Act of India. The Officers of the Embassy function under the guidance and supervision of the Ambassador.</p>
(iii)	The procedure followed in the decision-making process, including channels of supervision and accountability;	Decisions are taken as per extant rules and guidelines, where applicable and under the instruction and supervision of the Ambassador.
